I have served as Vice President for Student Affairs of three senior universities to include Grambling State University in Grambling, Louisiana, Jackson State University in Jackson, Mississippi, and Claflin University in Orangeburg, South Carolina.

In addition, I was able to provide value-added leadership in many areas of student development at these institutions. At Jackson, I administered more than a \$15.5 million dollar budget with auspices and accountability for 20 units. Understanding that self-motivation comes from self-knowledge, students should have freedom of inquiry and expression, but at the same time be obligated to exercise good judgment and maintain the highest standards of intellectual integrity. I am of the belief that students should be challenged It is my mission to develop in them the ability to think independently, accept responsibility, assess critical ideas, and to interact with others from diverse backgrounds. We need to adequately prepare students for careers and positions of leadership and develop their thirst for additional education through graduate and professional schools. In order for this to happen, students must be provided effective and sufficient counseling, which should help them to realize that their future lies chiefly in their own hands. Regardless of the nature of the institution, it is my belief that the students are the greatest asset and they give credence to the school's mission and existence. I am a firm believer that faculty, staff, and administrators must keep in mind at all times that the students are the most important resource at the institution.

In summary, creating successful partnerships with student affairs and academics is crucial to the success of an institution as it strives to provide and promote holistic learning for the students. When initiating a merger between the two areas, the students must be made to see the need as a vital component of their success which strengthens the university community as a whole. Institutions must work to bridge the gap between student affairs and academic affairs, or even eliminate it to satisfy the social, personal, emotional, and educational development of the students. The success demonstrated in achievement after collaboration between the two entities would prove to be phenomenal, and the goals of the institution for its students would be realized. It is exemplary of Abraham Lincoln's thought, "Together we stand; divided we fall." Uniting student affairs and academic affairs will ensure the fulfillment of the institution's mission, improved retention, and would improve the total college experience for students which illuminate the idea that "Students are our greatest asset and we are educating the whole student."
