Dear Search Committee:

Please accept the enclosed materials as an application for the position of Vice Chancellor for Student Affairs at the University of Tennessee at Martin.

I have excellent experience in a variety of areas relevant to supervision, collaboration and support within a college environment. I have worked with many critical areas on a college campus: admissions, orientation, crisis intervention, health services, retention, judicial affairs, financial aid, intramurals, student activities and organizations, first-year orientation classes, career services and leadership development. As the Vice Chancellor for Student Services, I had a pivotal position to be an advocate for students. From recruitment, admission and orientation to career services, we worked to bring our students a positive, successful and rewarding college experience. Enrollment of a student carries a responsibility to provide the services and support needed for the student to persist through graduation.

At the University of Arkansas at Monticello, I supervised a comprehensive Housing Office. This included staff training and development, room assignments and bill coding, Residence Life programming and community development, discipline, and working with food service management. In addition to working with residence hall renovation, I supervised the opening, management, and policy development for UAM's University Center. This facility contained a gym, locker rooms, weight room, exercise lab, faculty offices, classrooms, meeting rooms, the health services office, the campus activities office, snack bar, lounge, and the campus cafeteria.

My experience includes extensive knowledge of legal issues in a myriad of areas. I have been a judicial officer on five campuses. At the University of Arkansas at Monticello, I reconstructed our judicial system to decrease the time from the alleged violation to the hearing. We reduced the incident-to-hearing time from an average of 21 days to an average of two days with 80% of the hearings occurring within 24 hours. At the University of Arkansas Community College at Morrilton, I revised the student conduct and academic conduct codes. I have administered ADA compliance and accommodations, international student registration, student grievances, and sexual harassment complaints. At the University of Arkansas at Monticello, I lead a campuswide evaluation of all physical structures and programs for compliance with the Americans with Disabilities Act.

Working for five years supervising a comprehensive admissions program at a growing community college has provided me with extensive campus-wide experience. This included work in developing promotional materials, creating procedures and process to aid staff efficiency, expanding community ties and relationships, and working with all areas of the college

to maintain positive and productive relationships. This area also involved significant work in academic advising for incoming students.

I was the Coordinator of Minority Student Services at Radford University. I have been a champion of drug education for more than 20 years. I am a long time member of the *Arkansas Collegiate Drug Education Committee*, a statewide committee established to encourage and support drug education committees at all Arkansas colleges and universities. I was an officer for eleven years. It was in large part this work for which I received the 2004 Arkansas College Personnel Association Outstanding Leadership Award. I was the University Liaison to the Student Government Association for six years at UAM and I started the Student Government Association at UACCM.

Wellness models and wellness programming are the embodiments of the Student Affairs professional's concern for the whole individual. At UAM, I initiated a Wellness Committee that worked to focus, enhance and coordinate diverse campus areas within a wellness model. Our Committee brought together the campus religious organizations, the Greeks, the intramural program, Health Services, the alcohol education group, the Counseling Center, and Residence Life. At UACCM, we had fewer resources available. I started a walking program. In one year, our participants walked enough miles to equal the distance from Washington, D.C. to San Francisco, California.

An important aspect of a Student Affairs leader is the vision he or she holds for the role of Student Affairs within the institution. I believe that the most important task of Student Affairs is to provide students with the opportunities, the services and the resources to facilitate success. While the primary focus is academic success, Student Affairs should not limit itself or its students by looking only at academics. Student Affairs should be the center for promoting success in all areas. This can be accomplished through academics, counseling, organizations, intramurals, work-study, athletics, service learning or tutoring. Success in any area can be the foundation for building a successful college experience.

Our jobs are about trust. Parents, who send their daughters and sons to us, are entrusting us with the most precious thing in their lives. Adults, who come back to college as "non traditional" students, are entrusting us with their hopes and dreams for a better life. The success of each of these students is the fulfillment of this trust.

I enjoyed the broad scope that being the Vice Chancellor for Student Services at a two-year college provided. I supervised key offices and services and I worked with students on a daily basis. However, I am looking for the excitement of new challenges and the opportunity to provide energetic leadership in a positive and student-oriented institution.

It is at the core of residence life, discipline, security, athletics, food service and student organizations. Residence life is more than providing a place to live. It is an opportunity to teach leadership and valuing others. Campus security is more than writing parking tickets. It educates students on the importance of societal rules. There is a reason we stop at stop signs. We want our athletic teams to win but we want them teaching positive values as well. Within each of these areas, a AMaslow=s Hierarchy" exists. Residence life cannot educate about community responsibility, if it is not providing a clean, safe place to sleep. Campus security cannot link its actions to the larger issues of social responsibility, if there is no place to park. Larger educational issues cannot be developed, if we neglect the nuts and bolts of their meals, their rooms or their parking.
